Subject : Annual General Transfer – 2019 – Calling for willingness for posting to Kandla Customs and Mundra Customs in the grade of Superintendent and Inspector – M/Regarding.

In view of the ensuing Annual General Transfer -2019, willingness for posting to Customs Commissionerate, Kandla and Customs Commissionerate, Mundra (for combined period of four years) is sought from officers in the grade of Superintendents and Inspectors. Posting to the Customs Commissionerates of Kandla and Mundra are governed under the Transfer/Placement Policy for Customs Gujarat Zone issued from time to time.

2. It is requested to obtain/seek willingness from the eligible Superintendents/ Inspectors working under your charge along with duly certified/verified history of postings (each posting should bear full details e.g. name of range, division, Commissionerate in case of C. Ex. or CGST and name of the Customs formations, Section, Commissionerate in case of Customs) for postings to Kandla/Mundra. The consolidated list of willing and eligible officers may please be forwarded in the enclosed format in such a manner so to receive in this office **latest by 17.00 hrs of 26.04.2019.**

3. It may be ensured that willingness of only those Superintendents/Inspectors may be forwarded who have completed continuous tenure of four years in CGST (erstwhile Central Excise). The continuous tenure in CGST shall be counted from AGT to AGT. The respective controlling authority should ensure that willingness of officers eligible in terms of the Customs Policy, 2018 should only be forwarded.

4. Any willingness received after 26th April 2019 will not be considered. Advance copy of willingness will not be entertained.

5. This issues with the approval of Principal Chief Commissioner, Central Goods & Services Tax, Ahmedabad Zone.
